As a Principal Investigator what do I need to know before I submit a protocol using eProtocol?

Personnel Training

Once you create a protocol you will add your research personnel using the search feature; their demographic information, including WSU Access IDs, will populate automatically. If you have research personnel who are not affiliated with WSU and do not have an Access ID, please call the IACUC office at 313-577-1629.

Each person on the protocol needs to update their profile at CITIProgram.org by adding their Access ID to the Employee Number field (see the Steps to update CITI handout for further instructions). This step is critical because online training data from CITI cannot be imported without an Access ID.

You will need to send the IACUC office a list of everyone on the protocol (including yourself) with their Access IDs to iacuchelp@wayne.edu. The IACUC office will enter all training data that has already been completed (e.g. hands on DLAR training) into the system; this will include confirmation of AniCon questionnaire submission.

Everyone on the protocol <u>must</u> have all applicable online CITI training completed as well as an AniCon questionnaire on file with OEHS before the protocol can be submitted to the IACUC. A PDF link in the "Training Checklist" section of the protocol will allow you to see what training is required for each person on the protocol before you can submit the protocol and what is required before the protocol can be approved.

e-Signatures (certifications) and COI Disclosures

When you have finished completing your protocol, use the "Check for Completeness" function to ensure that all the questions have been answered. Once you have cleared all outstanding issues, the next step is to have your personnel "sign" your protocol.

Everyone on the protocol must both certify and answer the COI Disclosure in eProtocol (see the Steps for Research Personnel Certification handout). Each person will access eProtocol using the link above with their own Access ID and password. Because they have been listed on the protocol they will see it on their Investigator Dashboard. They will open the protocol and then proceed to the **Certifications** and **COI Disclosure** sections. eProtocol does not automate this e-signature process, so you will need to communicate directly with your team when you are ready to have them sign off on the protocol.

Once you have collected all e-signatures, you are ready to submit the protocol to your Chairperson for his/her sign off. Open your protocol in Edit mode and click "Submit Form"; you will be prompted to confirm that you want to submit the form to your Chair for certification. You can share the Steps for Chair Certification handout with your Chair for instructions on how to proceed. Once the Chair certifies and answers the COI question he/she will be prompted to send the protocol back to you so you can submit the signed protocol to the IACUC for the veterinary pre-review and subsequent Committee review.
